Official Government Updates

26/03/20 - UK government unveils aid for self-employed

The Government has announced a new self-employed income support scheme, which will provide self-employed people facing financial difficulties with 80% of their average monthly income, up to a maximum of £2,500. This will be calculated using their average monthly profits over last three financial years.

The scheme will initially last for three months, offering the same level of support for furloughed workers.

To be eligible, recipients must:

- Already be self-employed
- Have a self-assessment tax return for 2019 (a four week extension from today will enable people to submit a tax return if they missed the deadline)
- Have trading profits of up to £50,000
- Make the majority of their income from self-employment

HMRC are administering the scheme and aim for it to be live by June. Eligible recipients will be contacted directly and money paid directly into their bank account following application.

The scheme is in addition to all of the self-employed support measures already announced including access to Universal Credit, Coronavirus Business Support loans and HMRC support outlined at:

It is important that employers are clear regarding the help and support available and that they note that it is their responsibility to communicate this effectively to their employees.

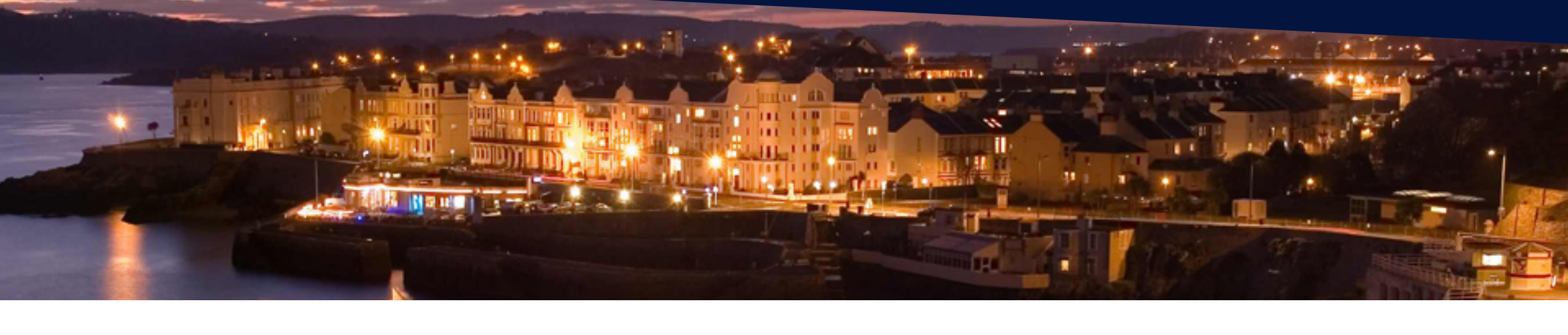

Plymouth's businesses are now able to apply for financial support to help get them through the current uncertainties created by the Covid-19 pandemic.

Construction Sector Updates

26/03/20 - CITB to suspend industry levy collection

CITB's board has given final approval to suspend the issue of its levy bills, due for payment in 2020, for an initial period of three months. The bills will subsequently be issued for the full year. The delay will provide immediate financial relief to construction employers during the coronavirus crisis. In normal times CITB assesses and sends out levy bills each April in accordance with legal requirements. CITB levy bills are usually due for payment in May, but CITB will not seek collection on the suspended bills until August, or later if possible.

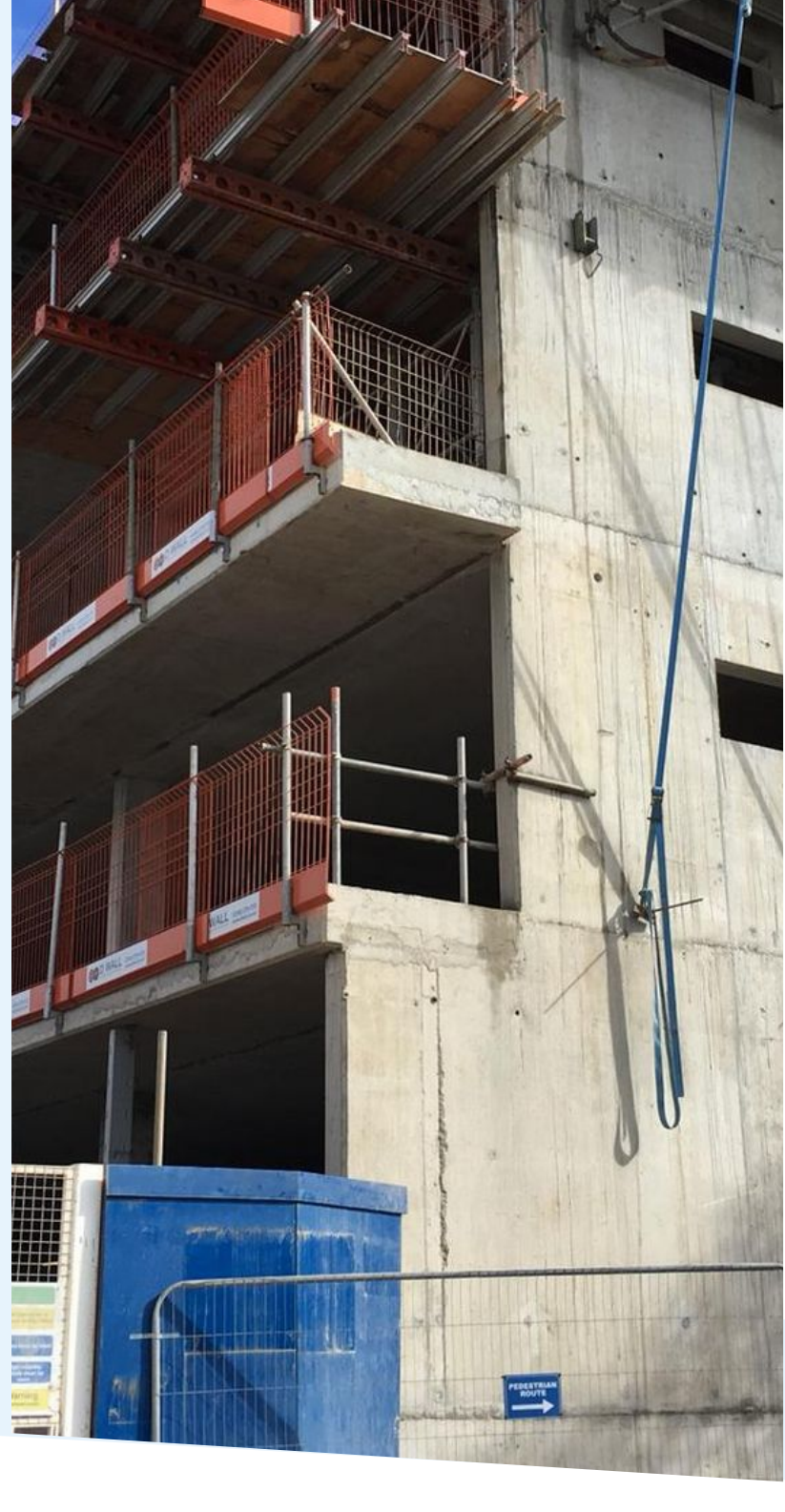

There is a 6 month exemption from MOT testing - if first MOT due exempted from needing a test from 30.03.2020. Vehicles need to be kept in roadworthy condition.

Companies House filing - Additional three months to file accounts.

ACTION REQUIRED!

26/03/20 - PPE needed call from Emergency Response Team Plymouth

As you will recognise the supply of personal protective equipment (PPE) to the care sector is fundamental for the good care of people with suspected symptoms of Covid-19. Whilst we are working rapidly with the government to ensure a longer-term supply of all aspects of personal protective equipment, including gloves, aprons, face masks and hand sanitiser, in order to support our services, our frontline staff and those that we are working to protect, we urgently need action to address the PPE stock levels in Plymouth.

As a city we are pulling together in our time of need and we hope that you can provide further support with donating any essential Protection equipment to support the COVID-19 emergency.

The types of things we need are:

- Disposable nitrile or latex free gloves
- Disposable aprons

- Medical face visors
- Full in one PPE body suits
- All in one PPE Body suits
- Disposable Shoe protectors
- Protectable sleeves
- 70% alcohol plus hand sanitisers
- Soap
- Paper towels or Alcohol wipes

Staying Healthy and Positive

Glayne's Top Tips

So how are you all doing in these difficult times? I appreciate that everyone will deal with the situation we find ourself in in very different ways. Living and working from home can be difficult as you no longer have that break. I have now been (almost) 2 weeks in #WFH and here are a few pointers that I have found have helped me to deal with this.

Keep in contact - with not only your friends, family but also your colleagues. Don't forget that you are used to being around them for the best part of 8hrs a day and having long periods of time working from home can leave you feeling isolated. Technology has been massively important and the use of MS Teams or Skype is a great way of doing this - video chat, Messenger, whatever form of communication best suited for the situation - the main thing is to keep in contact!

Routine - I believe that we are all 'creatures of habit' and routine is a great way of keeping focussed and staying alert as the days go by. Personally, I have tried to retain my Monday to Friday routine (other than an extra hour lie in due to not having to travel) and set myself targets for the day ahead. Sometimes these don't always go to plan (but they wouldn't necessarily go to plan in normal circumstances!). It also means that when I reach the weekend that I 'shut down' and do my new and very different 'weekend' tasks!

Exercising - whilst this can be difficult (with the current advice being only going outside once a day) don't forget that there are many on-line events / classes that are happening. I have found a couple which have been great. Not only is this good for

your physical wellbeing, it is also good for your physical wellbeing too (and don't forget you can also do this with your children if you have them!).

Listening to music - during the day my house can become very quiet - great for concentration but it can also drive you a little mad! I tend to put on some music - it really does help to keep me relaxed.

Control - just bear in mind that you can only be in control of some aspects of your life right now. I try not to stress about things that I cannot change (these will be different for everyone) but the sentiment remains the same.

Enjoy time in your home - I don't tend have that much time in my home as I am often out and about. Do the things that you've been putting off (if you can!); Tidy out that cupboard, fix that door. Whatever it is, you will feel accomplished once complete it!

So, these are just a few pointers of what I have found to be useful. They may help you or strike a chord with how you are dealing with life at the moment. They do not just relate to 'working from home' but also living day-to-day at the moment.

I believe that our world will have learnt so much about itself by the time we get back to 'normal'. Don't think that this is a negative - think about it as a positive. Take care and #staysafe
